Emeritus Professor and Schwab Endowed Chair in Social and Community Psychiatry at the University of Louisville. Founder & President, Billion Minds Institute, and Visiting Scientist, Harvard TH Chan School of Public Health. Former Executive Deputy Commissioner in the New York City Department of Health and Mental Hygiene where he led the Division of Mental Hygiene and its development and implementation of the innovative NYC-wide public mental health initiative, ThriveNYC. He was Medical Director for Behavioral Health across the Health and Hospitals Corporation of NYC. As Director of the NYU Program in Global Mental Health, he partnered with other groups globally to test and scale community-led models of mental health promotion and access in less resourced countries that are now widely used.

## In December 2018, the APA Board of Trustees approved the <u>Position Statement on Mental</u> <u>Health Equity and the Social & Structural Determinants of Mental Health</u> developed by the Council on Minority Mental Health & Health Disparities

#### The American Psychiatric Association:

 Supports legislation and policies that promote mental health equity and improve the social and structural determinants of mental health, and formally objects to legislation and policies that perpetuate structural inequities.





#### The American Psychiatric Association:

- Advocates for the dissemination of evidence-based interventions that improve both the social and mental health needs of patients and their families.
- Urges healthcare systems to assess and improve their capabilities to screen, understand, and address the structural and social determinants of mental health.





#### The American Psychiatric Association:

 Supports medical and public education on the structural and social determinants of mental health, mental health equity, and related evidence-based interventions.



- Urges medical school and graduate medical education
   accrediting and professional bodies to emphasize educational competencies in structural
   and social determinants of mental health and mental health equity.
- Urges psychiatry residency training directors and other psychiatric educators to use systematic approaches to teaching about structural and social determinants of mental health.
- Supports the training of psychiatrists, in graduate and continuing medical education, in best practices to address the structural and social determinants of mental health and promote health equity.



#### The American Psychiatric Association:

 Advocates for increased funding for research to better understand the mechanisms by which structural and social determinants affect mental illness and recovery and to develop new evidence-based interventions to promote mental health equity.
